

# **UNP Membership Report**

By Ron Klimley

All renewals have been received and as of July 31, 2019 total UNP membership is 147. For the last three years, our membership totals were; 2017 – 139, 2018 – 146, 2019 – 147. This represents a three-year trend of positive growth in membership for the club. I would like to challenge members to try and recruit one new member for 2020 so that we can continue our positive growth trend into next year.

121 of our members are from the United States with the remaining 26 members from other countries. As was the case last year we have 9 members from Germany, 5 members from Canada, 3 members from the Netherlands, and 2 members from Switzerland. In addition, we have one member from each of the following countries; Australia, Israel, Japan, New Zealand, Saudi Arabia, Singapore, and Turkey.

In the United States our membership reaches a total of 34 states with New York leading the way with a total of 15 members. California with 14 members and Massachusetts with a total of 9 members are the next two states with the highest membership. Florida, Illinois, Virginia, and Wisconsin each have six members. Pennsylvania and Texas both have 5 members while Connecticut, Tennessee, and Washington State all have 4 members. Maryland, Minnesota, Missouri, and New Jersey each have 3 members. Delaware, Iowa, Louisiana, Michigan, Nebraska, Oklahoma, and Oregon all have 2 members. Finally, the following states have one member each; Alabama, Arizona, Colorado, Georgia, Hawaii, Kentucky, New Hampshire, New Mexico, Ohio, Rhode Island, and West Virginia.

For 2019 we have 44 electronic members who access their journals on the web site. The number of electronic members in 2018 was 42 so we also have shown an increase this year in the number of our members who do not receive a printed copy of the journal.



# Vienna International Centre and UNPA Vienna 40th Anniversary

For many decades now, Vienna has positioned itself as a neutral bridge builder between East and West. 40 years ago, it finally happened – the Vienna International Centre was opened and has ever since made significant contributions to world peace. At the same time, the third United Nations Postal Administration office after New York in 1951 and Geneva in 1969 opened in Vienna in August 1979 and issued the first UN stamps in Austrian schillings.

On Friday, August 23, 2019, UNPA issued a new Personalized stamp sheet to commemorate 40 years Vienna International Centre as well as the 40<sup>th</sup> Anniversary of UNPA Vienna. The sheet, in the denomination of Euro 0.90 features ten stamps with five different designs of the VIC in Hundertwasser style. The tabs next to the stamps picture the VIC from different angles. The background design shows the United Nations emblem as well as the official "40 vears United Nations Vienna" logo and the text "Celebrating 40 years, UNPA / Vienna International Centre (1979 - 2019).

# UNPA Vienna Pre-Stamped Envelope Joint Issue With Austrian Post

On **Saturday**, **August 24**, **2019** and for the first time ever, the United Nations Postal Administration in Vienna issued a € 0.90 pre-stamped envelope as a joint issue with Austrian Post. The envelope in A6 format carries a design by Kurt Regschek and was printed in a quantity of 10,000 envelopes.

# Coast Guardman at the 1945 San Francisco Conference





Figure 1: US Delegation Admittance Card of Coast Guard RT-3/C Norris. Griffin. Signed by Durwood V. Sandifer, Secretary-General of the US Delegation

Coast Guard Radio Technician 3rd Class Norris Wayne Griffin was assigned to assist the United States Delegation at the UN Conference on International Organization (UNCIO), held in San Francisco, CA April 12 to June 26, 1945. The US Delegation, the largest delegation at the conference, occupied several floors of the Fairmont Hotel. Griffin's ID Card is shown in Figure 1.

It is not known what Griffin's duties were in assisting the delegation. One can assume that he had a role in providing radio communications for the delegation.

Apparently after about a month of working with the delegation, Griffin was reassigned to other work for the Coast Guard. On that occasion, he received a thank you

letter from Dorothy Gomez, a member of the delegation staff, writing on behalf of Edward R. Stettinius, Secretary of State and Chairman of the US Delegation. The letter, shown in Figure 2, was mailed in the cover shown in Figure 3 on May 15, 1945.






Figure 5: Cover to Griffin from Secretary of State at San Francisco, June 25, 1945.

When the conference closed with the signing of the UN Charter on June 26, 1945, Griffin received a thank you letter from the Secretary of State himself, under his own signature. This letter is shown in Figure 4. The cover containing the letter is shown in Figure 5.

Unfortunately, this letter and cover were such prized possessions that they were probably framed and hung on the wall, exposing them to light damage.

I wonder if the Secretary sent similar letters to all the other members and staff on the US delegation. If so, maybe some of them also survived. Watch for them!

Figure 4: Letter to Griffin from the Secretary of State, June 26, 1945



# The United Nations and Palestine: 1947-1951, Part 2






The special committee moved operations from Jerusalem to the European Office of the United Nations in the Palais des Nations in Geneva, Switzerland by 28 July. Two reports were finalized, a majority (two independent states) and a minority (single state) report were prepared for consideration by the 2nd General Assembly.

The majority report proposed dividing the mandate into two independent states for Arabs and Jews while Jerusalem was designated as an international city. The majority report was formally adopted on 29 November by the 2nd General Assembly, supported by Oswaldo Aranha of Brazil, John Foster Dulles of the United States and Aesgeir Aesgeirsson of Iceland.



# A History of UN Collecting - UN Clubs, Part 9

In this installment in our series on UN collecting we will take a look at our very own United Nations Philatelists, Incorporated (UNPI). The Club was started in the spring of 1977 by a group of seasoned collectors that had been the leadership of two chapters (New York and Chicago) of the long running United Nations Study Unit (UNSU). Having read some articles from Linn's and Stamp Collector from the 1976-1977 timeframe. it appears there were some concerns with the leadership of UNSU at the time, whom were predominantly NY collectors, not inviting a more broad representation on the executive committee of the organization. The leadership of these two chapters, and several well-known UN specialists from other parts of the country, met at COMPEX 77, in Chicago, Illinois, and together hammered out the requirements for creating a new UN club.




Fig. 1: Agenda of UNPI Organizing Meeting at COMPEX 77, Chicago




Fig. 3: Proof on Card of the chosen logo for UNPI

The original agenda from that meeting is shown in Figure 1. Note the new organization was initially called the United Nations Philatelic Group (UNPG), which was subsequently renamed UNPI during that initial meeting. Also considered during that meeting was the name United Nations Philatelists International. Two of the final actions of the organizational meeting was to select a UNPI Logo and to select the name of the club publication. It was decided that the logo should incorporate the then-current 2c definitive "Peace Dove" design. Figure 2 shows an un-adopted artist mockup design of the logo. Figure 3 shows a proof on card of the chosen design. The club publication name selected was "The Journal of the United Nations Philatelists."




Fig. 4: Original UNPI Board: Left to right: President Gus Knoeckel, Treasurer Jack Mayer, Vice President Paul Kravitz, Journal Editor Charles Berg, and Secretary Fred Bloedow. Board also included Ruth Grissman, Eileen Maissannes and Mike Meyer.

In conjunction with the COM-PEX 77 exhibition, the newly-formed UNPI and the UN Collectors of Chicagoland joined forces to host a special event at the Chicago Institute of Art. Here are some images from that historic gathering (Figure 4 & 5). News of the UNPI spread quickly with the major philatelic press providing a key role in providing collector awareness. Figures 6 & 7 present two such articles appearing in Linns Stamp News and Stamp Collector, respectively. Such publicity help the club quickly swell to nearly 400 members. In addition to the press promotion, work was already underway to showcase UN philately at a number of major philatelic exhibitions. This effort would lead to some of the finest UN exhibitions to be held in the U.S., as we shall explore in our next installment.

# United Nations Philatelists forms

United Nations Philatelists, a new organization for collectors of United Nations postal emissions and postal history has been formed.

The new group conducted its first official business meeting during COMPEX 77 in Chicago, May 28.

Serving as initial officers, for the term ending June 30, 1978, are Gustave Knoeckel of

Florida, president; Paul Kravitz of New York, vice president; Fred Bloedow of Illinois, secretary; and Jack Mayer of Washington, treasurer.

Ruth Grissmann of Iowa, Eileen Maisannes of New Jersey, and Michael Meyer of New York have been appointed directors at large for the new UNP organization.

The UNP executive board adopted bylaws, approved an open meeting policy, appointed committees of prominent U.N. philatelists for all parts of the U.S. to deal with a number of activities proposed by the UNP, and conducted a full schedule of other pertinent business.

The UNP board also established a publication to be known as "The Journal of United Nations Philatelists," which will be published at least six times a year.

Charles Berg of Illinois has been appointed editor of the publication, with R. Ginns of New York serving as associate aditor.



The adopted emblem of the United Nations Philatelists consists of a dove with an olive branch and the U.N. symbol.

Following the morning meetings, the UNP co-sponsored a luncheon at the Art Institute of Chicago, with the United Nations Collectors of Chicagoland, Inc.

Guest speaker Ole Hamann, chief of the U.N. Postal Administration, was presented with UNP Honorary Membership Number 1, along with a souvenir folder autographed by all in attendance.

Membership dues for the new organization have been set at \$6 for the period from the organization of the group through the end of its first membership year, Oct. 24, 1978 (United Nations Day).

Charter membership is open through Aug. 31, and the \$1 initiation fee to be charged after that date is waived for charter member applicants. After the first year dues will be \$6 annually

Treasurer Jack Mayer, 4114 R Ave., Anacortes, Wash. 98221, will provide additional information and a membership application on request. A large self-addressed, stamped envelope with requests is appreciated.

During the COMPEX 77 banquet, "Gus" Knoeckel, president of the UNP organization, was honored by UNPA chief, Ole Hamann, for his consistent promotion of U.N. philately. A suitably inscribed plaque was presented to the Florida-based collector.



With the establishment of the club came the desire to affiliate with some of the major philatelic organizations in the U.S., including the American Philatelic Society (APS) and the American Topical Association (ATA). Soon both organizations granted UNPI affiliate status, reaffirming UNPI's position as "The" recognized organization for all UN collectors. Figures 8 & 9 show the official letter, membership card, and official affiliate certificate from the APS, granting UNPI affiliate 71 status. Similarly the ATA granted the UNPI study unit status. Shortly following the APS recognition, the UNPI was invited to participate as an organization at the Annual APS STAMP-SHOW exhibition, held August 25-28, in San Francisco, California. This would set the stage for a lifetime of cooperation between the two organizations. Figures 10 & 11, STAMPSHOW souvenir card and special exhibition cachet signed by then-APS President, Emerson A. Clark.

Dues for the new organization were established at \$6 for the period from the organization of the UNP through the end of its first membership year, Oct. 24, 1978 (United Nations Day).






Fig. 12: Blank UNP Membership Card used for Charter Members. Charter Members are those that joined before September 1, 1977. Member Name and Membership Number were embossed on the card.





Fig. 13: Blank UNP Membership Card used for Members who joined UNP after September 1, 1977. Member Name, Membership Number and the Year were embossed on the card. At some point, this practice was discontinued.

During the early years of the UNPI, new members were provided a lovely permanent plastic membership card. Those who signed up for membership prior to September 1, 1977, received a special charter membership card in gold (Figure 12), all other membership cards were in blue (Figure 13). Figure 14 shows a small hand-drawn sketch of the original membership card layout. The design incorporated the UNPI logo that was selected during the initial meeting.




Fig. 17: First Issue of the UNP Journal, August 1977

As a key feature of membership, collectors received the club journal. Again, the philatelic press was very cooperative in announcing the new publication. Figures 15 & 16 show an early press release describing the first issue of the Journal from UNPI's first-President, Gus Knoeckel, and a subsequent article in Linns Stamp News promoting the publication. The Journal initially was printed in a small folded 8.5"H x 5.5"W format with a light blue cover (Figure 17). This format would remain for several years, although the blue cover was only used through the second issue, Volume 1, Number 2, and was then replaced by a white cover that has generally remained to this day. Starting with Volume 9, Number 4, in April 1986, the format was changed to 11"H x 8.5"W, and has remained that format to this day (Figure 19).

Fig. 14: Hand drawn sketch showing proposed Membership Card layout




Fig. 21: Wrapper from Journal #118, franked with UN stamps and mailed with blue UN cancel used for UN first day at Pacific 97 in San Francisco

The early Journals were placed in mailers and affixed with UN Postage for delivery to the UNPA for dispatch. Editor, Charlie Berg, in Chicago would send the copies to Associate Editor Ron Ginns, in New York. The editorial team comprised of Ron, Marcia Galletti, and myself would lick stamps for what seemed like days until all were finished. On our way home my mom and I would drop them off at the UNPA for mailing. In later years, we would affix the stamps directly to the outer wrapper of the Journal (This practice continues today). Figure 21 shows one such wrapper with a very special postmark from San Francisco during the US International show, Pacific 97. To my knowledge this is the only issue with UN stamps postmarked outside of NY. All other issues were posted at UNPA, NY until the UNPA changed their policies and would no longer allow for large bulk mailings. Thereafter, they were posted at various US Post Offices depending on where the

# Official Post Cards for UPU Congress, Stockholm-1924, Addendum

This is a follow-up to my article on the subject in the October 2014 issue of the Journal. For the UPU Congress, the Swedish post office produced a series of 23 different picture post cards. Please refer to the UN Conference Catalog (Ref. 2) for a complete listing. All of the official cards had the Congress emblem in the upper left corner of the message side (Fig. 1).

In the previous article, it was pointed out that Official Cards #6 and #7 were different from the other 21 cards in the series. It was concluded that these two cards were produced by taking an existing picture post card and adding the Conference emblem. All the other cards were different from commercial cards and would have to have been produced "from scratch".

In confirmation of the above conclusion, a duplicate card to Official Post Card #7 without the Congress emblem was shown in that article. Both the official card and the card without the Congress emblem were postmarked with the UPU Congress Strangnas postmark on July 16, 1924 for the delegate excursion to Strangnas.

It was speculated that such a duplicate card to Official Post Card #6 might also exist, and that we should be looking for it. Today, five years later, I am happy to report that such a card has been found. See Figures 2 through 5 below.

A search was made for other examples of Swedish post cards with the same image as was used on Official Post Cards #6 and #7. No identical images to Card #7 were found. For Card #6, no sepia images were found, but what appears to be the almost the exact same image as on Official Post Card #6 was found in color. This card, dated 1923, is shown in Fig. 6 and 7.

In the color card, the clouds are slightly different from the sepia cards, but many features, like the shadows in the water, are identical. The "Gripsholm" on the picture side is in a different place, but has the same type face. On the message side, the color card includes the printer logo, for "Svenska Letograpficka AB Stockholm". The sepia card has "69 A". Other than that, the message side is the same, with the exact same four lines for the address.

# Parcel post of the IAEA

Using parcel post from and to the "International Atomic Organization" documents of conferences, books, scientific publications and the like are usually sent. Nuclear irradiated material is not be sent by mail.

In 2005, the "International Atomic Energy Agency - IAEA" and its Director General, El Baradei, received the Nobel Peace Prize in equal parts.

Statement by the Norwegian Nobel Committee (quoted literally):



"The Nobel Committee has decided that the 2005 Nobel Peace Prize should be awarded in equal parts to the International Atomic Energy Agency (IAEA) and its Director El Baradei for their efforts to prevent the military use of nuclear energy and to ensure the most secure use of nuclear energy for peaceful purposes becomes. At a time of growing nuclear weapons threats, the Committee wishes to underline that this threat must be met with broad international cooperation. At present, this principle finds its clearest expression in the work of the IAEA and its Director-General. In accordance with nonproliferation rules (of nuclear weapons), the IAEA has control over the fact that nuclear energy is not misused for military purposes....



At a time when disarmament efforts seem deadlocked and there is a danger of nuclear weapons getting into the hands of terrorist groups, and as nuclear energy again seems to play a much more important role, the work of the IAEA is invaluable."




